3. I reside within the defined franchise area of Central Peace Natural Gas Co-op Ltd
4. I am not an individual who:
 - a. Is a dependent adult as defined in a Dependent Adult Act id the subject of a certificate of incapability under that ACT

 - c. Has been refused a license, or registered authorization of any kind by any regulatory body of any jurisdiction

 - e. Has been or is the subject of bankruptcy, insolvency, or receivership proceedings
 - f. Has been found guilty of a quasi-criminal offense under an Act of or of an offense under the Criminal act of Canada or similar legislation in other jurisdictions, for which a pardon has not been granted
 - g. Has any business, relationship, or interest (other than those interests of a member) with the Central Peace Natural Gas Co-op Ltd that could materially interfere with the ability to act objectively with a view to best interests of CPNGC
 - h. Is not an employee of Central Peace Natural Gas Co-op Ltd
 - i. Has been subject of judgement or order related to misrepresentation, theft, fraud, break of trust on the provision of products or services
 - j. Is involved in any litigation against Central Peace Natural Gas Co-op Ltd
 - k. Has been prohibited or otherwise removed as a director of an organization
